# Institution's Rules and Regulations for using Plagiarism Detection Software (DrillBit)

These guidelines can help ensure proper, ethical, and effective use of the software within an educational or organizational setting.

# 1. Purpose and Scope

• The institution employs DrillBit plagiarism detection software to promote academic integrity by identifying potential instances of plagiarism in submissions, including research papers / articles / thesis / project reports / institutional reports and other coursework of faculty, staffs members & student.

#### 2. Authorized Users

- Plagiarism checking is allowed to Faculty, Staff members and PG students of MCKVIE.
- PG students should sent the request through his / her institutional Guide / HOD / Coordinator.
- Institute Faculty member / Staff member requesting for Plagiarism check should be one of the authors of the paper.
- In case of Plagiarism checking for papers submitted as a part of institutional / departmental events, concerned coordinator / publication chair should forward the papers, after the 1<sup>st</sup> level of Plagiarism check is being done by the authors themselves.

# 3. User Responsibilities

- Ensure that all submitted academic work compiles with the institution's academic integrity policies.
- Use DrillBit to check the originality of student's work, staff member's articles, research papers, and prior to grading or publication.
- Users are responsible for reviewing the similarity reports generated by DrillBit and addressing any flagged content before final submission.

#### 4. Submission Guidelines

- All students written work are to be submitted through institutions faculties or staff members.
- All documents must be submitted in approved formats (e.g., .docx, .pdf, .txt) as specified by the institution.
- Maximum file size limits (100MB).
- Users can upload up to 15 files simultaneously.
- Each document can be up to 800 pages in length.
- Users should submit documents only through the official DrillBit platform or integrated institutional systems.
- A maximum of five (5) plagiarism checks are permitted per faculty/staff member per year.



# 5. Confidentiality and Privacy

- Submitted work will be stored securely within DrillBit's database to facilitate future plagiarism check.
- Users consent to their submitted work being stored in DrillBit's database for future similarity comparisons unless otherwise stipulated by institutional policy.
- The institution and DrillBit will not disclose submitted content to third parties without user consent, except as required by law.

### 6. Use of Similarity Reports

- Similarity reports generated by DrillBit are tools to assist in identifying potential plagiarism; they do not automatically determine academic misconduct.
- Faculty and academic committees will review reports in context to make fair judgments.
- Users may be required to provide explanations or revisions for flagged content.

#### 7. Submission Procedures

- All staff members are hereby requested to send their papers in soft copy to library mail (library@mckvie.edu.in) for checking plagiarism.
- It is advised to write only "Plagiarism Check" in the subject area and name, department and employee ID & purpose in the body area of the e-mail.
- Report along with original script will be sent to you as soon as possible.

#### 8. Prohibited Actions

- Do not attempts to manipulate, bypass,
- Do not use commercial purpose.
- Sharing of accounts or credentials is strictly prohibited.
- Do not use for personal documents checking.
- Do not uses for class notes, answers script checking.
